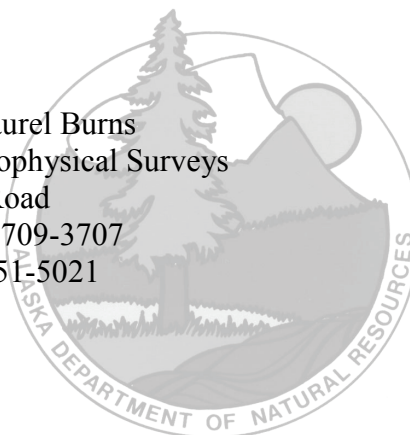
#### ***Parts of Tanacross, Iditarod, and Ophir quadrangles***
