### TAX CREDIT SEISMIC DATA TERMS AND CONDITIONS

## Ordering and Payment

Order requests must be done using the DGGs online, tax credit seismic data order form available at <http://dggg.alaska.gov/gmc/seismic-well-data.php>. The price of the seismic data is valid on the order date and may be subject to change. Applicable prices are available from the State of Alaska or the current edition of the order form for the data. Updated order forms and website content will be made available if the prices change.

After the order request has been placed, the State of Alaska will confirm the request and the requestor's affiliation, and invoice the buyer for the tax credit seismic data. The invoiced amount is payable to the State of Alaska via credit card, check, or electronic fund transfer; cash will not be accepted. The data will be provided to the requestor once the requestor acknowledges and accepts these terms and conditions and the invoiced amount has been received by the State of Alaska.

## Data Usage Conditions for Purchased Data

Tax credit seismic data **purchased** from the State of Alaska have been provided with the intent that they be readily available for public or private use without further permission from the State of Alaska, Department of Natural Resources. There are no licensing agreements or other restrictions when purchasing the data.

Products derived from tax-credit seismic data purchased from the State of Alaska **must cite** the data and its source. This data should be cited as follows:
